- Must be a NY Water customer
- Must provide a copy of dated sales receipt/paid invoice showing manufacturer, model number, installation date, and purchase price
- Product must be purchased on or after April 1st, 2024
- Smart irrigation controllers and rotating sprinkler heads must be WaterSense labeled

## Terms and Conditions:

**Rebate Overview:** Liberty Utilities (New York Water) Corp. (“Liberty”) is implementing an enhanced water conservation program to encourage water saving measures which will consist of a few programs as outlined in its recent rate case (Public Service Commission Case 23-W-0235). One of the customer offerings includes irrigation system incentives, which encourages residential, irrigation, and C&I customers to purchase select irrigation equipment upgrades, including weather-based irrigation controllers, rotating sprinkler nozzles, drip irrigation kits, and rain barrels. In connection with the irrigation system incentives program, this rebate (“Rebate”) is only valid for qualifying equipment purchased on or after April 1, 2024 and is subject to the terms and conditions contained herein.

**Application:** Customers apply for rebate consideration directly to Liberty. The application and any required documentation must be filled out completely and accurately and must be submitted via email or mail. Details of this Rebate, including Rebate levels, are subject to change or cancellation.

**Eligibility:** Funds available for Rebates are limited. This Rebate is valid for water Customers in the Liberty territory on a first come, first served basis. To be eligible to participate in the Rebate, Customers must receive service by Liberty.

**Approval, Verification, and Inspection:** Prior to any payment of a Rebate, Liberty reserves the right to verify sales transactions. Smart Irrigation Controllers, and Rotating Sprinkler Heads must be EPA WaterSense labeled. All Rebate submissions are subject to post inspection.

**Required Documentation:** The sales receipt/invoice must indicate the equipment type, model number, purchase date, and purchase price. Liberty reserves the right to not pay any Rebate if the application form and all required additional information are not complete and accurate.

**Payment:** Please allow up to six weeks for processing. Payment processing may be delayed if required documentation or information on the application is incomplete or missing. **Tax Liability:** Liberty shall not be responsible for any tax liability that may be imposed on the Customer as a result of the payment of a Rebate.

**Incentive Amounts:** The program will provide incentives for approved equipment, equal to the incentive amount indicated in the company's program literature and with the program application. Rebates are not available on refurbished or used equipment. The program reserves the right to change its incentive amounts in addition to negotiating a lower incentive amount. The incentive may not exceed the installed cost of the equipment (excluding any taxes).
